### **1. TEACHING**

#### **Teaching Nr. 1. EU Law**

Person in charge: Luis Arroyo Jiménez.

Academic year: 2019/20.

Teaching: September 2019-January 2020.

Hours taught by the chair holder: 60.

Evaluation: January 2020 (ordinary) and June 2020 (extraordinary).

Methodology: Lectures and seminars.

Number of enrolled students: 134.

Syllabus: 1. Nature and evolution of the EU. 2. EU Institutions and the process of decision-making. 3. EU law and the national legal orders. 4. The judicial system of the EU. 5. Fundamental rights. 6. Internal market.

Impact: The course challenges the student not only to understand, but also to critically assess the structures, methods, and content of EU law. At the end of the course students have a thorough understanding of the EU integration process and EU institutions; a clear understanding of the sources, nature, and application of EU law, as well as of how to enforce their rights at national and European level; and a deep knowledge of the landmark judgments of the Court of Justice of the EU. The course helps to consolidate the study of EU law within the degree in law, providing students with knowledge of EU subjects relevant for their academic and professional lives.

#### **Teaching Nr. 2. Economic Public Law**

Teaching: February-May 2020.

Hours taught by the chair holder: 45.

Evaluation: June 2019 (ordinary) and July 2019 (extraordinary).

Methodology: Lectures and seminars.

Number of enrolled students: 23.

Syllabus: 1. The Economic Constitution. 2. Economic and Monetary Union. 3. Fundamental freedoms. 4. Competition Law. 5. Services of General Economic Interest. 6. EU law of the financial markets.

Impact: The course provides students with an advanced understanding of the main topics of EU economic public law, ranging from the general foundations of the EU economic constitution and the EMU to the crosswise (freedoms of movement and competition) and sector-based market regulation (SIEG and financial markets). In this respect, the course helps to consolidate the study of EU law within the degree in law, as well as to promote, give visibility and consolidate the study of EU integration issues in the area of economic law.

Teaching: March 2020.

Hours taught by the chair holder: 20.

Evaluation: March 2020.

Methodology: Seminars.

Number of enrolled students: 18.

Syllabus: 1. Global Governance. 2. Administrative Law beyond the State. 3. Global Administrations. 4. European Administrations. 5. Global Rulemaking. 6. Global Rules Enforcement. 7. Democracy and the Rule of Law beyond the State. 8. Global Sanctions. 9. COVID-19 and Global Public Health. 10. Investment Dispute Resolution.

Impact: The course is focused on global and European administrative law, and it explores these two areas of law and their mutual interactions from four different perspectives: their normative foundations, their main actors, the functions that they perform, and some areas where they overlap. It took a tentative, yet close look at the health emergence that was outbreaking in March 2020. The program comprises 25 lecturing hours (18 hours taught by the chair holder).

## **2. RESEARCH**

### **Research Nr. 1. European Administrative Law**

Current status: 50% (to be concluded in 2022).

Description: European Administrative Law is the law that governs EU law administrative implementation. This research will deal with it from two perspectives. On the one hand, European Administrative Law is now internally developing from a rather unstructured body of rules towards a more or less rationalized order. Expounding substantive principles (legitimacy, effectiveness, good administration, etc.) and elucidating formal structures (rulemaking, single-case decisions, procedure, co-operation, etc.) are the main avenues of this process of doctrinal construction. On the other hand, European Administrative Law operates as an interface between Global Law and the national legal

orders. The external dimension of EU agencies and the procedures and forms of incorporation of global standards into EU law are the most important topics in this respect.

Impact: This project is related with the first part of a research project under the national competitive research program of the Spanish Government (2019-2021) on “Administrative law beyond the State” (PI: Luis Arroyo Jiménez) (2019-2021) (<https://blog.uclm.es/catedrajeanmonnet/2019/09/18/administrative-law-beyond-the-state/>). It will allow us to understand and to critically assess the current development of European Administrative Law. In particular, (i) it will promote excellence in research on the two groups of issues that have been mentioned; (ii) it will also enhance and structure future academic research on this topic; (iii) it will enrich the debate between academics and stakeholders involved in European Administrative Law; and (iv) it will consolidate the internationalization of the research activities of the Chair’s members. Deliverables Nr. 1 and 2 contain the results of this project. Deliverable Nr. 1 will assure open access to the main results.

## **Research Nr. 2. Global Public Law**

Current status: 75% (to be concluded in 2021).

Description: Many different actors of public, private and hybrid nature operate in the global arena. They produce rules and standards, implement them in particular cases and solve disputes between both public and private parties. Moreover, some of those actors are entrusted with the performance of tasks and functions related to executive governance. The set of rules, principles and doctrines that steer the latter in the global arena is often called Global Administrative Law or Global Public Law. European Administrative Law and Global Public Law are connected in significant ways. This interface gives rise to a rich communication flow of political impulses, legal techniques, and regulatory policies, that might be problematic in terms of legitimacy and effectiveness. The aim of this project is to explore these interactions and the problems stemming thereof.

Impact: This project is related with the second part of the research project under the national competitive research program that has been mentioned in Research Nr. 1. It will let us understand better and to critically assess the current development of Global Public Law. In particular, (i) it will promote excellence in research on Global Public Law, specifically on its relationship and interactions with European Administrative Law; (ii) it will also enhance and structure future academic research on this topic; (iii) it will enrich the debate between academics and stakeholders involved in EU law enforcement; and (iv) it will consolidate the internationalization of the research activities of the Chair’s members. Deliverables Nr. 1 and 2 contain the results of this project. Deliverable Nr. 1 will assure open access to the main results.

### **Event Nr. 1. International Conference on *The Modernization of European Administrative Law***

Description: The two workshops on Global Public Law and Regional Integration in Latin American Perspective foreseen in the description of the project were going to take place within the framework of a postgraduate course on Global Public Law for Latin American students, which finally was not offered in 2019/20. For this very reason they had to be cancelled. However, these events were replaced by the VI Conference of the International Network on European Law (VI RIDE Conference), which was devoted to *The Modernization of European Administrative Law*, an issue that perfectly fits within the scope of the activities of the chair. The event touched upon topics such as EU administrative procedure, principles of law, soft law, Europeanisation of national legal systems, and so on (<https://blog.uclm.es/catedrajeanmonnet/2019/12/20/the-modernization-of-european-administrative-law/>).

Impact: The conference has allowed around 30 University professors and researchers from 6 Member States of the EU to present the result of their on-going research projects, fostering dialogue and interchange of ideas between academics.

### **Event Nr 2. Workshop of the Project on *Administrative Law Beyond the State* (in the framework of the VI RIDE Conference)**

Description: Within the framework of the VI Conference of the International Network on European Law (VI RIDE Conference), which was devoted to *The Modernization of European Administrative Law*, a workshop was organized. Three young scholars could present their work-in-progress on environmental, competition, and energy EU law. The event touched upon topics such as EU administrative procedure, principles of law, soft law, Europeanisation of national legal systems, and so on environmental, competition, and energy EU law.

Impact: The conference has allowed around 30 University professors and researchers from 6 Member States of the EU to present the result of their on-going research projects, fostering dialogue and interchange of ideas between academics. The workshop, in particular, let young scholars discuss their work-in-progress with other colleagues.

Impact: This event has helped to disseminate the result of the chair's activities among the general public and civil society representatives, thus giving greater visibility to these European issues both within and outside the University.

Since the Center and the School of Law and Social Sciences are located in different cities, co-operation between the Center and the Chair generates synergies in terms of disseminating their respective activities and reinforces the impact of the University action in the field of EU studies at a regional and national level. Thus, the Center helps the Chair Academic Staff to disseminate its activities via their new website (<https://www.uclm.es/centros-investigacion/cee/>) and social media (@CEEUCLMTOLEDO) while, in turn, the Chair provides the Center with valuable academic and technical support (drafting programs and chairing panels in academic events, integrating prize award committees, etc.). Isaac Martín is Director of the Center and member of the Chair’s team, while the holder of the latter is the Center’s Director of Research.

## **6. IMPACT**

Implemented activities have so far benefited different target groups, both within and outside the University of Castilla-La Mancha.

First, students of the Law degree have benefited from curricula with a notable presence of EU law: 134 students have attended the general course on EU law (Teaching Nr. 1), 23 enrolled in the elective course on Economic Public Law (Teaching Nr. 2) and almost 20 have learned the fundamentals of European and Global Administrative Law (Teaching Nr. 3).

Second, the International Conference on the Modernization of European Administrative Law (Event Nr. 1) has allowed around 30 University professors and researchers from 6 Member States of the EU to present the result of their on-going research projects, fostering dialogue and interchange of ideas between academics.

Third, young researchers have had more opportunities to develop their academic careers, both at a national and international level, engaging in research activities (Research Nr. 1 and 2), academic publications (Deliverables Nr. 1 and 2). Particular emphasis must be made on the International Conference on the Modernization of European Administrative Law (Event Nr. 1). This event has given a number of young researchers and professors (from the UCLM and other Spanish and EU universities) the opportunity to share and discuss their work in progress.

Finally, the general public at local and regional level has profited from having a



University more open to European issues thanks to our Website, to the *Jean Monnet* Lectures Series (Event Nr. 2).
