Teaching Nr. 1. EU Law

Academic year: 2020/21.

Teaching: September 2020-January 2021.

Hours taught by the chair holder: 60.

Evaluation: January 2021 (ordinary) and June 2021 (extraordinary).

Methodology: Lectures and seminars.

Number of enrolled students: 138.

Syllabus: 1. Nature and evolution of the EU. 2. EU Institutions and the process of decision-making. 3. EU law and the national legal orders. 4. The judicial system of the EU. 5. Fundamental rights. 6. Internal market.

Impact: The course challenges the student not only to understand, but also to critically assess the structures, methods, and content of EU law. At the end of the course students have a thorough understanding of the EU integration process and EU institutions; a clear understanding of the sources, nature, and application of EU law, as well as of how to enforce their rights at national and European level; and a deep knowledge of the landmark judgments of the Court of Justice of the EU. The course helps to consolidate the study of EU law within the degree in law, providing students with knowledge of EU subjects relevant for their academic and professional lives.

Evaluation: June 2021 (ordinary) and July 2021 (extraordinary).

Methodology: Lectures and seminars.

Number of enrolled students: 14.

Syllabus: 1. The Economic Constitution. 2. Economic and Monetary Union. 3. Fundamental freedoms. 4. Competition Law. 5. Services of General Economic Interest. 6. EU law of the financial markets.

Impact: The course provides students with an advanced understanding of the main topics of EU economic public law, ranging from the general foundations of the EU economic constitution and the EMU to the crosswise (freedoms of movement and competition) and sector-based market regulation (SIEG and financial markets). In this respect, the course helps to consolidate the study of EU law within the degree in law, as well as to promote, give visibility and consolidate the study of EU integration issues in the area of economic law.

Methodology: Lectures and seminars.

Number of enrolled students: 33.

Syllabus: 1. Foundations of Global Public Law. 2. Principles of Public Law beyond the State. 3. Actors of Global Public Law. 4. Functions: Rulemaking and Enforcement. 5. Areas of Global Public Law. 6. Conflict Resolution beyond the State.

Impact: The course is focused on global public law and explores the implications of EU law in the development of this new area of law. The problems stemming from the coexistence of various interrelated legal systems are analyzed, alongside the existing rulemaking, law enforcement and adjudication models. The course is a postgraduate program offered by the University of Castilla-La Mancha and specifically addressed to students from Latin America. Its methodology is blended, and it has 80 hours of classroom teaching (25 hours taught by the chair holder).

2. RESEARCH

Research Nr. 1. European Administrative Law

Current status: 75% (to be concluded in 2022).

Description: European Administrative Law is the law that governs EU law administrative Implementation. This research will deal with it from two perspectives. On the one hand, it is now internally developing from a rather unstructured body of rules towards a more or less rationalized order. Expounding substantive principles (legitimacy, effectiveness, good administration, etc.) and elucidating formal structures (rulemaking, single-case decisions, procedure, co-operation, etc.) are the main avenues of this process of doctrinal construction. On the other hand, European Administrative Law operates as an interface between Global Law and the national legal orders. The external dimension of EU agencies

and the procedures and forms of incorporation of global standards into EU law are the most important topics in this respect.

Impact: This project is related with the first part of a research project under the national competitive research program of the Spanish Government (2019-2021) on “Administrative law beyond the State” (PI: Luis Arroyo Jiménez) (2019-2021) (<https://blog.uclm.es/catedrajeanmonnet/2019/09/18/administrative-law-beyond-the-state/>). It will allow us to understand and to critically assess the current development of European Administrative Law. In particular, (i) it will promote excellence in research on the two groups of issues that have been mentioned; (ii) it will also enhance and structure future academic research on this topic; (iii) it will enrich the debate between academics and stakeholders involved in European Administrative Law; and (iv) it will consolidate the internationalization of the research activities of the Chair’s members. Deliverables Nr. 1 and 2 contain the results of this project. Deliverable Nr. 1 will assure open access to the main results.

Description: Many different actors of public, private and hybrid nature operate in the global arena. They produce rules and standards, implement them in particular cases and solve disputes between both public and private parties. Moreover, some of those actors are entrusted with the performance of tasks and functions related to executive governance. The set of rules, principles and doctrines that steer the latter in the global arena is often called Global Administrative Law or Global Public Law. European Administrative Law and Global Public Law are connected in significant ways. This interface gives rise to a rich communication flow of political impulses, legal techniques, and regulatory policies, that might be problematic in terms of legitimacy and effectiveness. The aim of this project is to explore these interactions and the problems stemming thereof.

Impact: This project is related with the second part of the research project under the national competitive research program that has been mentioned in Research Nr. 1. It will let us understand better and to critically assess the current development of Global Public Law. In particular, (i) it will promote excellence in research on Global Public Law, specifically on its relationship and interactions with European Administrative Law; (ii) it will also enhance and structure future academic research on this topic; (iii) it will enrich the debate between academics and stakeholders involved in EU law enforcement; and (iv) it will consolidate the internationalization of the research activities of the Chair’s members. Deliverables Nr. 1 and 2 contain the results of this project. Deliverable Nr. 1 will assure open access to the main results.

It has touched upon various topics such as regional organizations, global regulatory regimes, international economic law, soft law, and so on.

Impact: The workshop has allowed civil servants, private practitioners and academics to share academic and professional experiences, fostering dialogue between the academic world and policymakers.

It was based on a lecture given by Jamile Mata Diz aimed at comparing regional integration process in Europe (EU) and in Latin America (Mercosur). It gave rise to a fruitful discussion with the participants in the Course on Global Public Law.

Impact: The workshop has allowed professors and researchers to civil servants, private practitioners and academics to discuss the similarities and peculiar features of Mercosur and the EU.

Description: This is a two-session workshop with University students. The first session focused on the principle of precaution, while the second one dealt with the case law and international arbitration on renewable energy under the Treaty on the Energy Charter.

Impact: The workshop has allowed researchers, practitioners, and students of the University of Castilla-La Mancha to approach two of the most pressing issues of Energy and Environmental EU law.

The dissemination strategy also counts on the “Luis Ortega Álvarez” European Studies Center of the Castilla-La Mancha University (<http://blog.uclm.es/ceuropeos/>). Since the Center and the School of Law and Social Sciences are located in different cities, co-operation between the Center and the Chair generates synergies in terms of disseminating their respective activities and reinforces the impact of the University action in the field of EU studies at a regional and national level. Thus, the Center helps the Chair Academic Staff to disseminate its activities (@CEEUCLMTOLEDO) while, in turn, the Chair provides the Center with valuable academic and technical support (drafting programs and chairing panels in academic events, integrating prize award committees, etc.). Isaac Martín is Director of the Center and member of the Chair’s team, while the holder of the later is the Center’s Director of Research.

6. IMPACT

Implemented activities have so far benefited different target groups, both within and outside the University of Castilla-La Mancha.

First, students of the Law degree have benefited from curricula with a notable presence of EU law: 138 students have attended the general course on EU law (Teaching Nr. 1), 14 enrolled in the elective course on Economic Public Law (Teaching Nr. 2) and almost 33 have joined the course on Global Public Law (Teaching Nr. 3).

Second, the Workshops on Global Public Law (Event Nr 1) and Regional Integration (Event Nr 2) in Latin American Perspective on have allowed around 30 University professors and researchers to present the result of their on-going research projects, as well as to discuss the interplay between European and Latin American perspectives, fostering dialogue and interchange of ideas.

Third, a number of students at the School of Law and Social Sciences have had the opportunity to approach some of the most pressing issues within EU environmental and energy law in a two-session workshop with the participation of top specialists in these fields of law (Event Nr 3).

Fourth, the general public at local and regional level has profited from having a University more open to European issues thanks to our Website, and to the *Jean Monnet* Lectures Series (Event Nr. 4).

Finally, young researchers have had more opportunities to develop their academic careers, both at a national and international level, engaging in research activities (Research Nr. 1 and 2), events (Events Nr 1, 2 and 3), and academic publications (Deliverables Nr. 1 and 2).
