The Draft will follow the systematic of the Framework Decision on the European Arrest Warrant. The communications -presented by advance- will have been gotten up in it and also the information about the particularities of the European Arrest Warrant in each one of the Member States of the European Union.

The content of the debates and the communications presented by the assistants will be gotten up to the Guide, which will be published in English, French and Spanish with the financial support of the "Agis" Program of the European Commission.

The Seminar will have like result a Document about Good Practices on the European Arrest Warrant.

National experts will attend the Seminar by each one of the 25 Member States of the European Union, as well as members of organs, institutions and agencies of the European Union with competences in the matter of Justice and Home Affairs.
